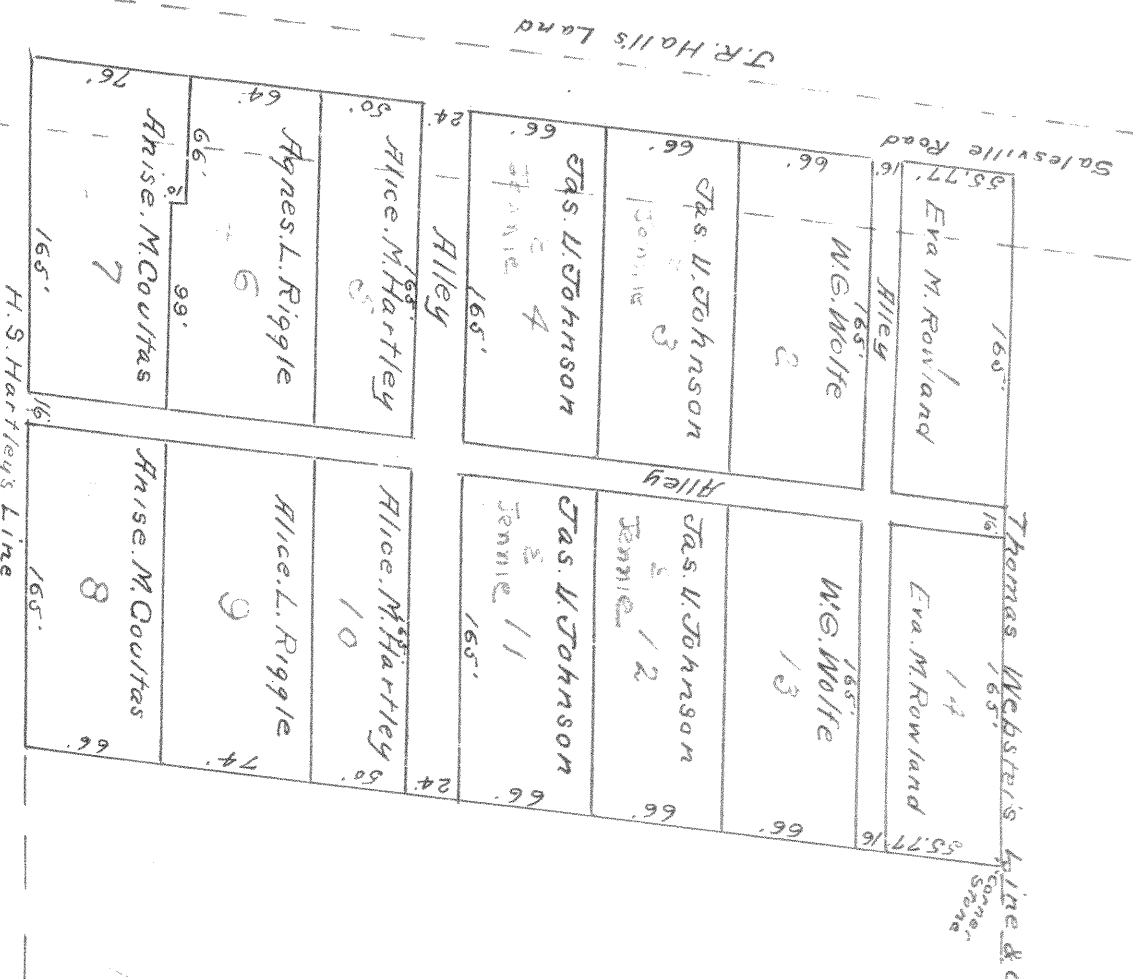
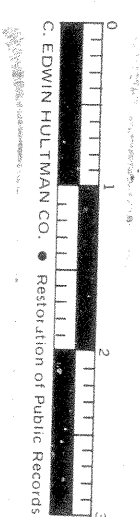


Walter H. Webster's Addition
