

# MCFARLAND'S THIRD ADDITION TO CAMBRIDGE OHIO




The north line of this addition lies 765.7 ft.

North of the south line of lot numbered (4) East.

McFarland's Third Addition to the City of Cambridge is made up of 345 feet, with exceptions noted on plat, off of the west side of lot numbered four (4) East, adjoining (but now included in) said City of Cambridge, and containing .6 acres, as the same was laid off and platted by the Commissioners for that purpose appointed by the Court of Common Pleas of Guernsey County, Ohio, in a certain action in partition, wherein Robert B. Moore et al., were plaintiffs and Zachariah Beatty was defendant, said lot #4 East having been conveyed to William H. McFarland in four separate tracts by deeds recorded, respectively, in Volume 34, page 577, Volume 35, page 344, Volume 36, page 479, and Volume 53, page 164, of the Deed Records, of said County of Guernsey. The boundaries of this "Addition" are indicated by red lines.

I hereby certify that the accompanying plat is a true representation of the streets, avenues, alleys and lots into which the said premises are divided.


