## PLAT OF AN ADDITION TO MILLWOOD

PLAT OF AN ADDITION LAID OUT TO THE TOWN OF MILLWOOD BY MR. JONAH SMITH THE PROPRIETOR THERE OF IN MILLWOOD TWP. GUE. CO. OHIO. THE ORIGINAL PLAT OF SAID TOWN AS DESCRIBED ON THIS STREET WITHIN DOTTED LINES THE SAME BEING THE LOTS NUMBERED FROM 1 TO 20 THE ALLEY NUMBERED FROM 1 TO 5 THE STREETS BEING NAMED SENECAVILLE, BARNESVILLE AND FAIRVIEW EACH BEING 4 PERCHES WIDE THE ALLEYS BEING 1 PERCH WIDE, THE MERIDIAN THEREON WILL SHOW BY RECOURSE HAD TO THE ORIGINAL MAP THE SITUATION OF EACH LOT THERE FROM THE INLOTS NOW LAID OUT. IN ADDITION WILL BE FOUND TO ALSO CORRESPOND TO THE ORIGINAL RIGHT ANGLED LOTS. THOSE NOW LAID OUT ON FAIRVIEW ST. NO. 21,22,23,24,25,26,27 AND 28 IS OR MEASURES 4 PERCHES WIDE IN FRONT BY 10 BACK EACH CONTAINING 40 SQ. PERCHES WITH AN ALLEY BETWEEN TWO OF THEM 1 PERCH WIDE SAID LOTS FORMING RIGHT ANGLE WITH FAIRVIEW ST. & BEARING N.50°E. BY N.40°W. THE BEGINNING FOR SAID LOTS BEING AT A STONE PLANTED AT THE S.W. CORNER OF LOT NO.21. THE INLOTS OF ADDITION NOW LAID OUT FRONTING ON SENECAVILLE ST. NUMBERED 29,30,31,32, 33,34,35,36,37,38, AND 39 AND 42,43,44,45,46,47,48,49,50,51,52,53 EACH BEING 4 PERCHES WIDE FRONTING ON SAID ST. BY 10 BACK CONTAINING 40 SQ. PERCHES OF LAND EACH. THESE LOTS BEARING WITH S.81°W. AT RIGHT ANGLES WITH NORTH 9°W. THE LOTS NO. 40 AND 41 DESCRIBED AS FOLLOWS viz. NO. 40 BEING 4 PERCHES IN FRONT BY 3 PERCHES AT THE BACK IN BROADTH THE ANGLES OF THE SAME WHERE IT CORNERS WITH LOT NO. 39 CORRESPONDS THERE WITH THE SAID LOT CONTAINS 35 SQ. PERCHES (i.e.) LOT NO. 40. 1 LOT NO. 41 BEING ALSO A FRACTION IS 1½ PERCHES WIDE IN FRONT BY 3 PERCHES WIDE AT THE BACK AND THE ANGLES BEING THE SAME AND CORRESPONDING THERWITH WHERE IT CORNERS WITH LOT NO.42 AND CONTAINS 22.5 PERCHES SQ. AN ALLEY LYING BETWEEN EACH TWO OF THESE LOTS EXCEPT 3 S.W. OF ALLEY 12. THE BEGINNING STONE FOR THESE LAST MENTIONED LOTS WILL BE FOUND AT THE S.E. COR. OF LOT NO.29 THE BACK LOTS LAID OUT NUMBERED 1,2,3,4,5,6,7,8,9 FRONT OF THE BACK ALLEY PARRALEL WITH THE BACK OF LOTS NO. 2 AND 32 1 PERCH THERE FROM EACH OF SAID LOTS BEING 4 PERCHES WIDE FRONTING ON SO. ALLEY BY 8 PERCHES BACK CONTAINING EACH 32 SQ. PERCHES WITH AN ALLEY 1 PERCH WIDE BETWEEN EACH TWO OF THEM SAID OUT-LOTS FROM RIGHT ANGLES BY SO.81°W. & N.9°W. FROM SAID ALLEY THE BEGINNING STONE FOR THE SAME BEING AT THE S.E. COR. OF OUTLOT NO.1. THE DESCRIPTION OF ALL THE ALLEYS MAY BE HAD BY LOOKING AT THE MAP.
