

COVENANTS - CONDITIONS AND RESTRICTIONS I NO DWELLING HOUSE SHALL BE CONSTRUCTED OF OTHER THAN FRAME, BRICK, OR STONE CONSTRUCTION

- ALL STRUCTURES SHALL BE BUILT IN A LOCATION AT LEAST 30 FEET LACK FROM THE FRONT BOUNDARY LINE OF EACH LOT
- ALL STRUCTURES SHALL BE LOCATED AT LEAST 10 FEET DISTANT FROM THE BOUNDARY LINES ON EITHER SIDE OF EACH LOT
- ALL DWELLING HOUSES SHALL BE BUILT WITH AT LEAST 1400 SQ. FEET OF AREA OR FLOOR SPACE, INCLUDING GARAGE AND BREEZ WAY
- NO DWELLING OR BUILDING SHALL BE ERECTED FOR ANY PURPOSE OR USED FOR ANY PURPOSE, OTHER THAN RESIDENTIAL.
- ANY GARAGE OR CAR PORT THAT IS BUILT MUST BE ATTACHED TO THE DWELLING HOUSE
- NO MORE THAN ONE DWELLING HOUSE SHALL BE ERECTED ON EACH PLATTED LOT
- NO MERCANTILE, BUSINESS, COMMERCIAL, FACTORY OR TRADE MAY BE CARRIED ON WITHIN THE ADDITION.
- ANY PORTION OF A LOT MARKED WUTILITY AREAW IS SUBJECT TO A PERPETUAL EASEMENT FOR THE INSTALLATION, REPAIR AND MAINTENANCE OF WATER, GAS, ELECTRIC AND SEWER LINES AND NO BUILDINGS OF ANY KIND MAY BE CONSTRUCTED THEREON.
