WE THE UNDERSIGNED, OWNER OF THE LAND SHOWN IN THIS PLAT, ACKNOWLEDGE THAT WE HAVE CAUSED THE SAME TO BE SURVEYED AND DIVIDED AS SHOWN, AND WE ASSENT TO AND ADOPT THE SAME. - \*ONLY ONE SINGLE FAMILY DWELLING OR COTTAGE, WITH GARAGE, MAY BE ERRECTED ON EACH LOT.
- \*SANITARY FACILITIES MUST BE CONTAINED WITHIN THE COTTAGE OR DWELLING.
- \*THE FLOOR AREA OF ANY DWELLING OR COTTAGE SHALL EXCEED 450 SQUARE FEET, EXCLUDING GARAGE, BASEMENT AND PORCHES.
- \*ALL LOTS ARE SUBJECT TO UTILITY EASEMENTS AS REQUIRED.
