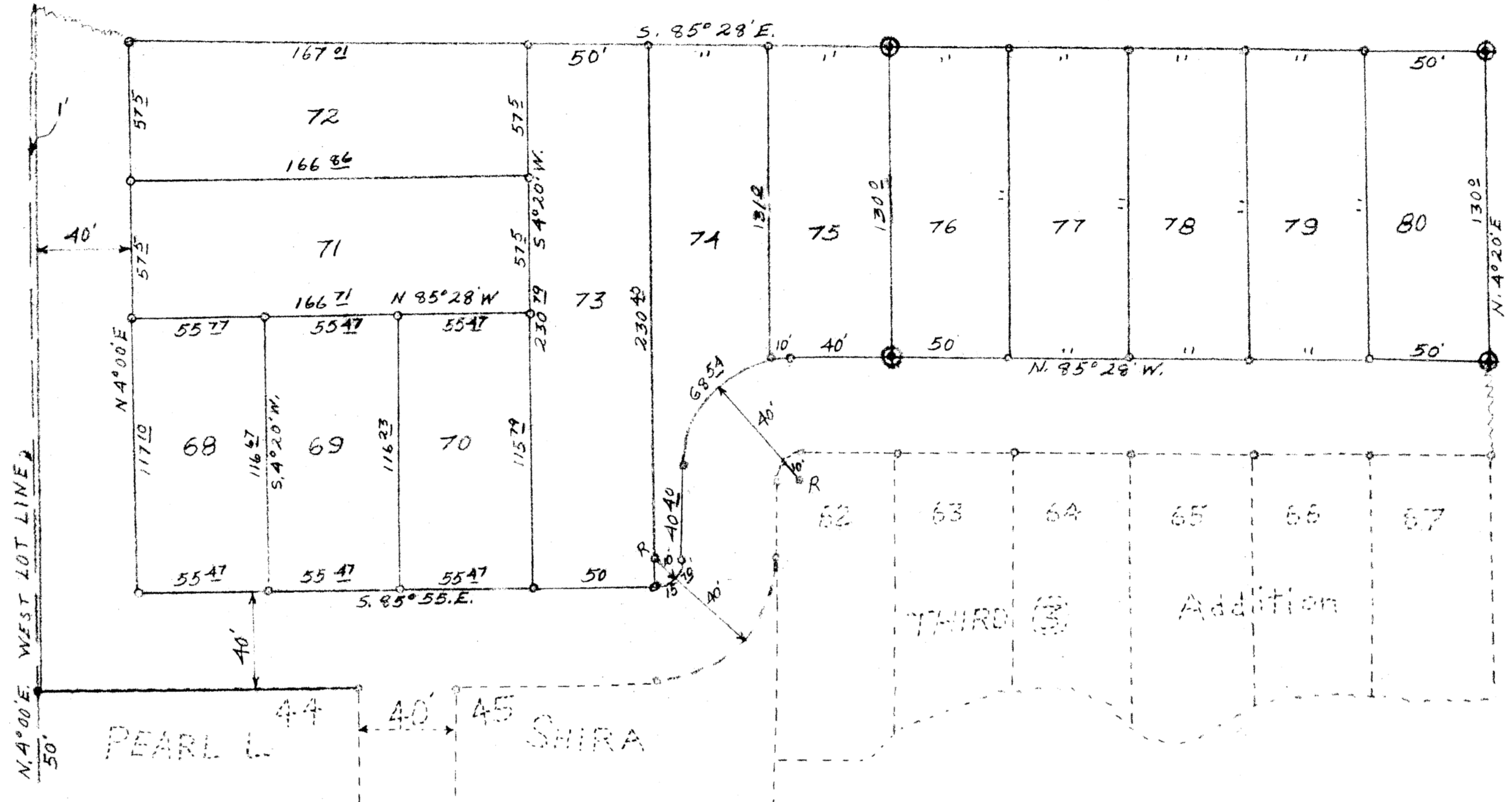


PEARL L. SHIRA
