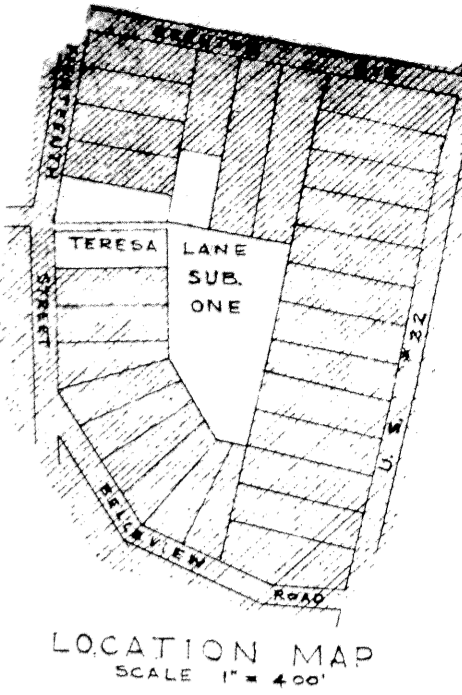

CLAIRMONT AVE

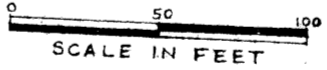
EIGHTEENTH STREET
