


N.W. $\frac{1}{4}$ OF THE N.W. $\frac{1}{4}$ OF SEC. 25. TWP. 10 R. 7.

Range 7. thence East 9.71 chains. thence S 30° E. 4.75 chains. Thence S 60° W. 6.75 chains. Thence S 71° W. 2.0 chains thence North 2.50 chains. Thence N 71° E. 0.63 chains. Thence N 30° E. 2.75 chains thence S 71° W. 1.06 chains. Thence S 19° E. 2.75 chains thence N 71° E. 0.63 chains. thence South. 2.50 chains thence S 71° W. 2 chains. Thence N 19° W. 5.25 chains thence S 71° W. 0.16 chains to sec.line. Thence N 3.77 chains to the place of beginning containing 6.83 Acres. Said Tract of land is marked 1-1-1 on accompanying plat.
