We the undersigned citizens & qualified voters of said county residing in said territory of said county, contiguous to the incorporated Village of Cambridge in the County aforesaid: pray that the following described territory of said county, in which we reside being contiguous to said Village be annexed to said incorporated Village of Cambridge. A map of which territory is hereto attached marked "A" "to wit" Commencing for the same at the S.E. cor of lot No. 1 in loflands first addition to said Village running thence due west to the S.E. cor. of lot No. 11 in loflands first addition to said Village thence due south to a point on the south bank of Wills creek thence with the south & southwest banks of said creek in a N.W. direction to the Central Ohio Rail Road bridge thence east across said creek to the east bank thereof thence in a northern direction with the east bank of said creek to the N.W. cor. of out lot No. 1 in loflands 2nd addition to said Village thence due east to Walnut St. in said Village at a point 20ft north of the N.E. corner of said lot No. 1 in said loflands first addition to said Village thence due south to the place of beginning. And do hereby authorize & empower John M. Bushfield, esq. to act in our behalf in prosecuting this petition. Notice Notice is hereby given that on the 9th day of Sept. A.D. 1869 a petition was presented to the commissioners of Gue Co. Ohio & filed on said day in the Auditors office in said county and praying that the following territory of said county contiguous to the incorporated Village of Cambridge be annexed to said Village "to wit" Commencing for the same at the southeast corner of lot No. 1 in loflands first addition to said Village running thence due west to southeast corner to lot No. 11 in loflands said first addition to said Village thence due south to a point on the south bank of Wills creek thence with the south bank of Wills creek in a southwesterly direction to the Central Ohio R.R. Bridge thence east across said creek to the east bank of said creek thereof thence in a northern direction with the east bank of said creek to the N.W. corner of out lot No. 1 in loflands second addition to said Village thence east to a point 20ft north of the N.E. corner of said lot No. 1 in loflands first add. to said Village. Be it Ordained by the incorporated Village of Cambridge that the petition of Samuel Metcalfe & others for the following Territory to the Village "to wit" Commencing for the same at the S.E. cor. of lot No. 1 of loflands first Add to said village running thence due west to the S.E. cor of lot No. 11 in loflands first Add to said village Thence due south to the point on the South bank of Wills Cree Thence with the S & Southwest bank of said creek to the C.O. RR. bridge thence east across said creek to the east bank thereof. Thence in a northern direction with the east bank of said creek to the N.W. cor. of Out lot No. 1 thence due west to walnut st. at a point 20ft north of the N.E. cor of lot No. 1 in loflands first add to said Village thence due south to the place of beginning. be accepted & the said territory described in said Petition is hereby declared a part & parcel of said incorporated Village of Cambridge and the inhabitants thereof to have & enjoy all the rights & privileges of said incorporated Village Done in Council this 7th day of Mar.
