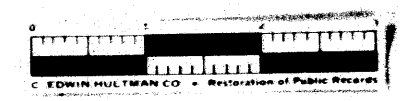
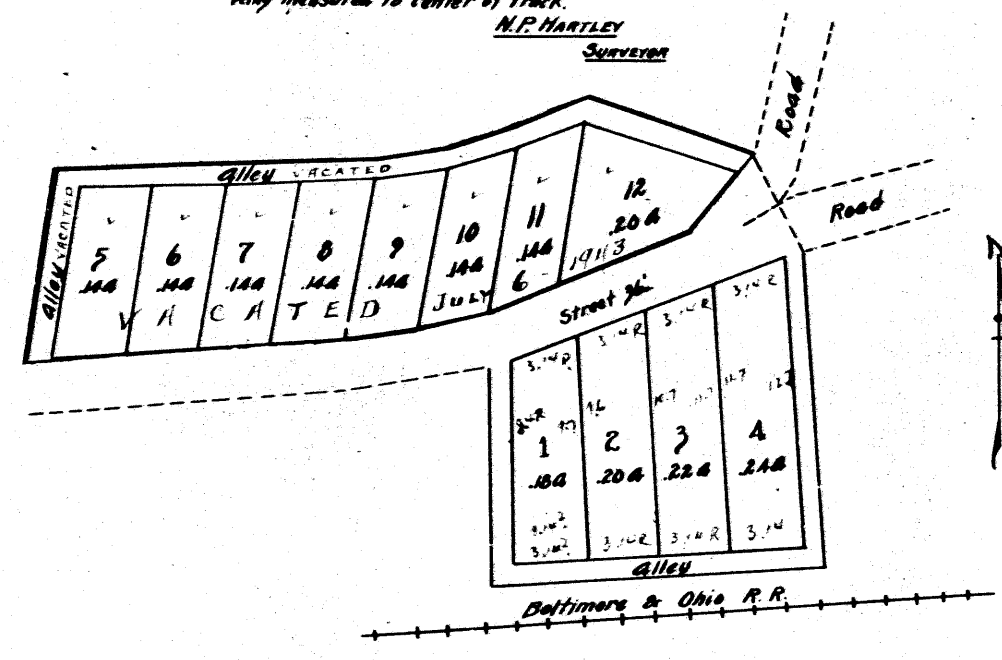


PLAT OF HARRIS ADDITION TO THE VILLAGE OF SPENCERS STATION

DISCRPTION

The following is a description of the lots in Harris Addition to the Village of Spencers Station in Guernsey Co. Ohio being 12 lots, 4 lots on south side of Highway and 8 lots on the North side of Highway and situated as follows: Lots 1-2-3-4 on south side and 7-8-9-10-11-12 on the North side. Lot #1 begins on road N 67° E from the corner of a lot owned by the Trues, thence South 85° roads.
